

Final WWGA Board Meeting Minutes-June 30, 2026

The meeting was held in the Sales Center and called to order by Renee Gibb at 2:05pm. Board members in attendance: Renee Gibb, Leslie Hotaling, Sue Bowman joined telephonically, Mary Lawrence Melvin, Jen Adams, Shirley Marcus Buckner. Sally Johnston attended.

The minutes of the May 12, 2026 meeting were approved via email. The minutes have been posted on the WWGA website.

There was a discussion of summer tournaments. The handicap sections are excerpts from the descriptions developed by the Woods Handicap Committee.

2026 Invitational Tournament

Friday, July 10, 2026-Mountain View

To date, we have 68 registrants-63 paid

17 teams, 2 person teams with best ball format and the net of the 2 players

The budget is being re-calculated. Discussions are currently underway regarding prizes-how many, how much?

Mixed Derby

Saturday, July 18, 2026 – Mountain View Course

The Board approved a course handicap requirement for the Mixed Derby this year per the recommendation of the Woods Handicap Committee.

HANDICAP: Course handicaps for WWGA members must be 46 or less from the gold tees and for WMGA members, course handicaps must be 38 or less from the member tees. For the men, the Rule of 85 applies and eligible WMGA members can play from the green tees. A percentage allowance will then be applied to the player's course handicap to arrive at their playing handicap.

2026 MIXED SHAMBLE

Saturday, August 1, 2026 – Mountain View Course

The Board approved a course handicap requirement for the Mixed Shamble this year per the recommendation of the Woods Handicap Committee.

HANDICAP: Full course handicaps are allowed, and a percentage of each player's course handicap will be applied to determine the team playing handicap. The Rule of 85 applies for WMGA players.

The remaining summer tournaments will be discussed at our next meeting.

There may be by-laws changes for the 2027 season after a full evaluation of the 2026 season and of how the current handicap system impacts each tournament. The goal is to ensure that as many WWGA players as possible have the opportunity to play in tournaments.

At the suggestion of Mona Zammetti, Renee Gibb will forward a letter of appreciation to individuals responsible for designing and maintaining the flower beds on the course.

Shirley Marcus Buckner volunteered to be responsible for WWGA bereavement notifications. Upon notification by a WWGA member or immediate family member, a sympathy card will be sent on behalf of WWGA in the death of a WWGA member, WWGA spouse or WWGA son or daughter. Additionally, WWGA active members will be notified via email of the death and any known funeral arrangements.

Mary Lawrence Melvin presented the June, 2026 treasurer's report. She agreed to submit a revised report which will reconcile with the WWGA Microsoft 365 reports.

Donna Pike has agreed to be the 2027 Tuesday games coordinator. Karen Schroeder will assist her.

The WWGA Clothes Swap will be held on Wednesday, August 5th in the Sales Office.

A Nominations Committee needs to be established. Renee Gibb will chair. Representation is needed from Stony Lick players.
