July 27, 2023

1. The meeting was held at The Woods Sales Center and started at 4:00 pm. Sheryl Dolin, Laura Word, Barbara Hageman, Renee Gibb, Liz Shaw, Wendy Smith, Sue Walker, Cindy Gresham, Sally Johnston, and Ron Springer were in attendance.
2. Minutes from the July 6th meeting were approved via email and posted to the website.
3. Women's Club Championship:
